-RFP: for the 1st round of opioid settlement dollars.

-Reissued another RFP specifically for early intervention.

-We will release that RFP on February 1st due March 15th.

-Up to \$500,000.

-we wish to fund 2-3 agencies.

-2 informational webinars (not required), highly recommended.

-Opioid focused.

-Prioritizing agencies who has not received county dollars and smaller non-profit agencies (meaning less than a million dollars in your annual budget) Due March 15th.

-MOU definition: program services that encourage early identification of interventions of children/adolescents that may be struggling with problematic drug use or mental health conditions.

-Allows early intervention by providing peer base programs or training for parents, youth etc.
